#### **Ivan Atanassov**

AgroBioInstitute, Bulgaria

Prof. Ivan Atanassov is director of the AgroBioInstitute /ABI/, Agricultural Academy at the Ministry of Agriculture, Food and Forestry in Bulgaria. He obtained his PhD degree in Genetics in 1994 at Institute of Genetic Engineering (now AgroBioInstitute). His research carrier involves a number of successful research projects in ABI and postdoctoral fellowships in different labs in Japan and Europe on a broad range of research topics in the field of cellular and molecular biology and biotechnology. Since 2000, he has been leading the Molecular Genetics Group at ABI. In 2017 he was appointed as director of the institute.

In 2017, prof. Atanassov was nominated by the Bulgarian Ministry of Agriculture, Food and Forestry as national representative in SCAR and coorganised the national SCAR meeting in Bulgaria on 28 February, 2018.



## **Enrico Prezio**

DG Research & Innovation, European Commission, Brussels

Mr. Enrico Prezio is working as a policy officer at DG Research & Innovation of the European Commission. He coordinates the development of the International Bioeconomy Forum (IBF) initiative. He also coordinates the Directorate's contribution to briefings, reports and other documents relating to international cooperation. In addition, he manages studies and consultations aimed at the preparation of new EU policies and/or amendments thereof. Before Mr. Enrico Prezio worked as a legal officer at DG Research & Innovation and as a financial officer at Research Executive Agency (REA) and at DG Communications Networks, Content and Technology (CNECT).













# Krijn Poppe

Wageningen Economic Research, Wageningen University & Research, the Netherlands

Dr. Krijn Poppe works as a senior economist at Wageningen University & Research, currently in a position as Research manager at Wageningen Economic Research. One day a week he works as a member of the Council for the Environment and Infrastructure that advises the Dutch government. He supports decision makers in policy and business to understand and act upon trends in agri & food and (co)manages various research programmes for the European Union on the European food industry, ICT and on research infrastructures for food and health, and the farm accountancy data network (FADN).

For several years he was co-leading the EU SCAR's strategic working group AKIS (Agricultural Knowledge an Innovation Systems) and he currently leads an expert group on Food2030 (DG RTD) that helps to design the research agenda for the 9<sup>th</sup> Framework Programme on research and innovation.



#### **Bozhidar Ivanovo**

Institute of Agricultural Economics, Bulgaria

Dr. Bozhidar Ivanov is associate professor in the Institute of Agricultural Economics (IAE) making studies on the commodity markets, agricultural policy and sustainable development. He is one of the leading Bulgarian experts in agricultural economics and policy. He accomplished a number of studies on country agricultural developments following Bulgaria accession to EU.

He obtained a PhD degree in Agricultural Science from the Kyushu University, Japan. Since 2013, he has been coordinating the Centre for Agri-Policy Analysis – CAPA, as cooperation of IAE and Food and Agricultural Policy Research Institute at the University of Missouri USA.













#### Jan van Esch

Ministry of Agriculture, Nature and Food Quality, The Netherlands

Mr. Jan van Esch is bioeconomy strategy and research advisor at the Ministry of Agriculture, Nature and Food Quality in the Netherlands. Since 1992 Mr. van Esch is working in the ministry in the field of Agriculture, Innovation and bioeconomy. Part of his work is to represent the Netherlands in International organisations, like FAO, the International Energy Agency, the Bioeconomy international advisory board and several EU working groups.

Jan van Esch is co-chairing the SCAR Strategic Working Group Bioeconomy and has a role as observer in the Bioeconomy Stakeholders Panel.



#### Svetlana Boyanova

Institute for Agrostrategies and Innovations, Bulgaria

Ms. Svetlana Boyanova is the chairwomen of the Institute for Agrostrategies and Innovations. She began her career as a Senior expert in the Ministry of Agriculture and Forestry. In 2003 she was a legal advisor at the Confederation of Employers and Industrialists in Bulgaria. Afterwards, she was consecutively executive director of the Bulgarian Association of Agricultural Producers (BAAP) and Deputy Minister of Agriculture and Food, in charge of land relations, Direct payments and Rural Development Program.

Ms. Svetlana Boyanova is a member of the SCAR Strategic Working Group AKIS. She graduated in law at the Bourgas Free University, Bulgaria.



#### Kalliopi Radoglou

Democritus University of Thrace in Greece.

Prof. Kalliopi Radoglou works at the Department of Forestry and Management of Environment and Natural Resources at the Democritus University of Thrace in Greece. She is professor in Forest Ecophysiology since 2012. She also has long experience as senior researcher at the Forest Research Institute - DIMITRA in Thessaloniki in the field of climate change impacts and environmental stress on Mediterranean tree species and ecosystems. She has been involved in several European research projects. Currently she is scientific responsible for the projects LIFE FORESMIT and SUMFOREST.

Since 2011 she has been a member of SCAR and since 2016 she is vice chair of the SCAR Strategic Working Group FOREST.













#### **Rolf Stratmann**

Dr. Rolf Stratmann is scientific officer at the Project Management Department at the Forschungszentrum Jülich in Germany. The Forschungszentrum Jülich is one of the largest interdisciplinary research institutions in Europe.
