- 1974 Regulation of the EU Council;
Coordination of agricultural research
in scope of the Common Agricultural Policy
- 2005 Revised mandate; reflecting change to the
scope of agricultural research agendas;
provision of advice to European
Commission and EU Member States
 - » Coordination and collaboration with KBBE-NET
(Knowledge-Based Bio-Economy Network)

Background and brief history

KBBE-NET (European Commission driven)

- 2005 Third annual progress report of the Life Science and Biotechnology Strategy published in 2005:

The Commission will ...“establish a network with EU Member States to help **coordinate the development and implementation of a European research policy for a *Knowledge-Based Bio-Economy* in coordination with the Standing Committee on Agricultural Research**”.

Main role: Support the Commission and Member States towards the building of a Knowledge-Based Bio-Economy in Europe

- End 2011 KBBE-NET dissolved; SCAR to cover the whole Bioeconomy; Bioeconomy Observatory, ...

SCAR developments

Reflection Paper 2/2

- **Option 1:** Limit focus to activities addressed by the Committee pre-2012 in recognition of the constraints on resources of both the European Commission, the Member and Associated Countries.
- **Option 2:** Continuing the current approach – a resource constrained evolution of SCAR in response to a changing landscape (“business as usual”).
- **Option 3:** Building on option 2, extending towards a stronger strategic role based on the availability of more resources.
- **Option 4:** Building on option 3, extending towards a wider input to all areas of the Bio-economy relating

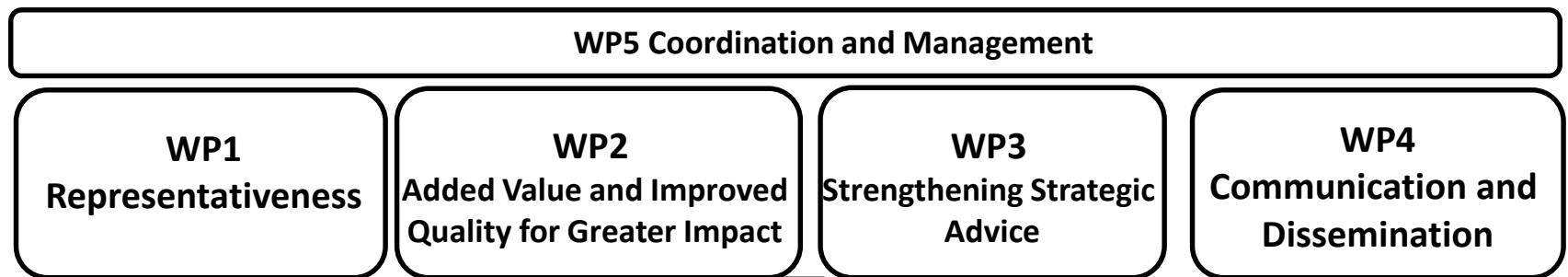
Specific CASA objectives:

- **Improved overall organisation, communication and dissemination** of SCAR activities, outputs and outcomes for greater impact

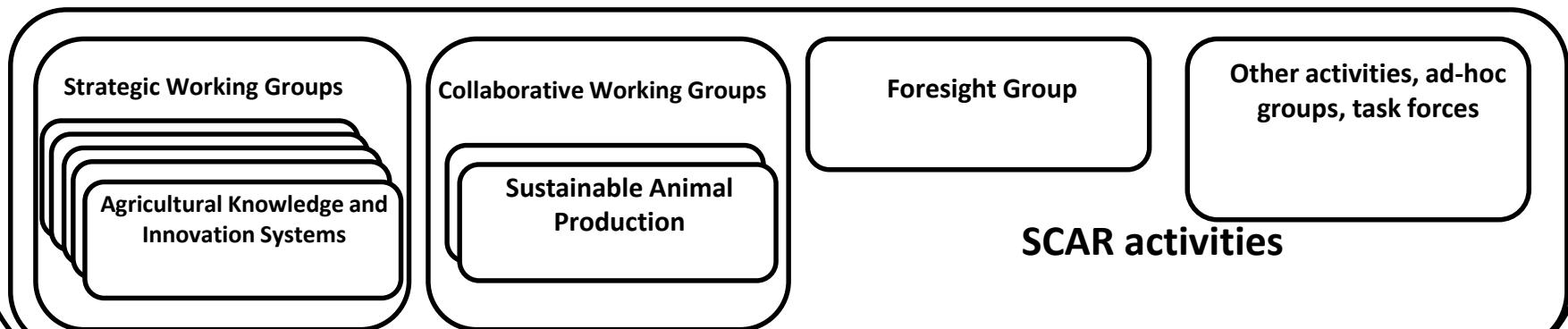

CASA Work Packages for reaching the Specific Objectives

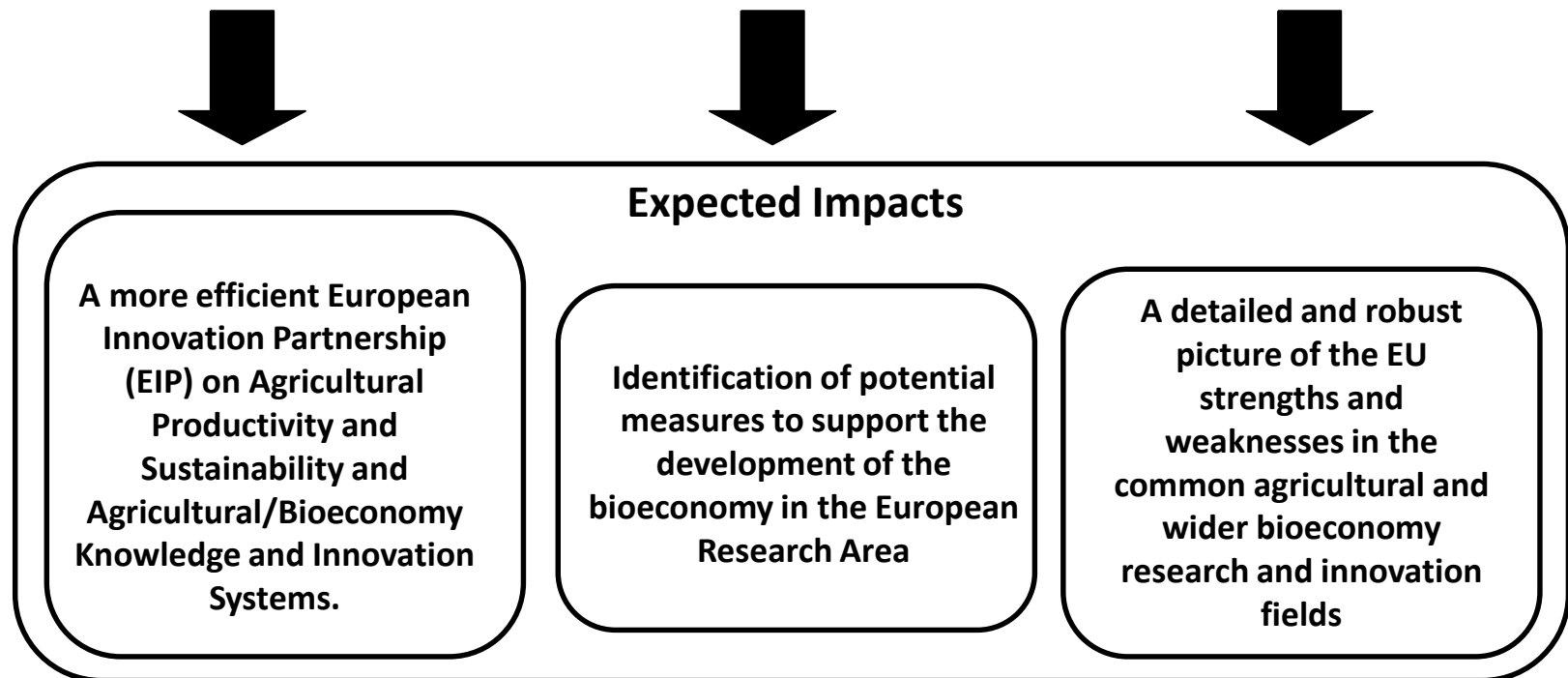

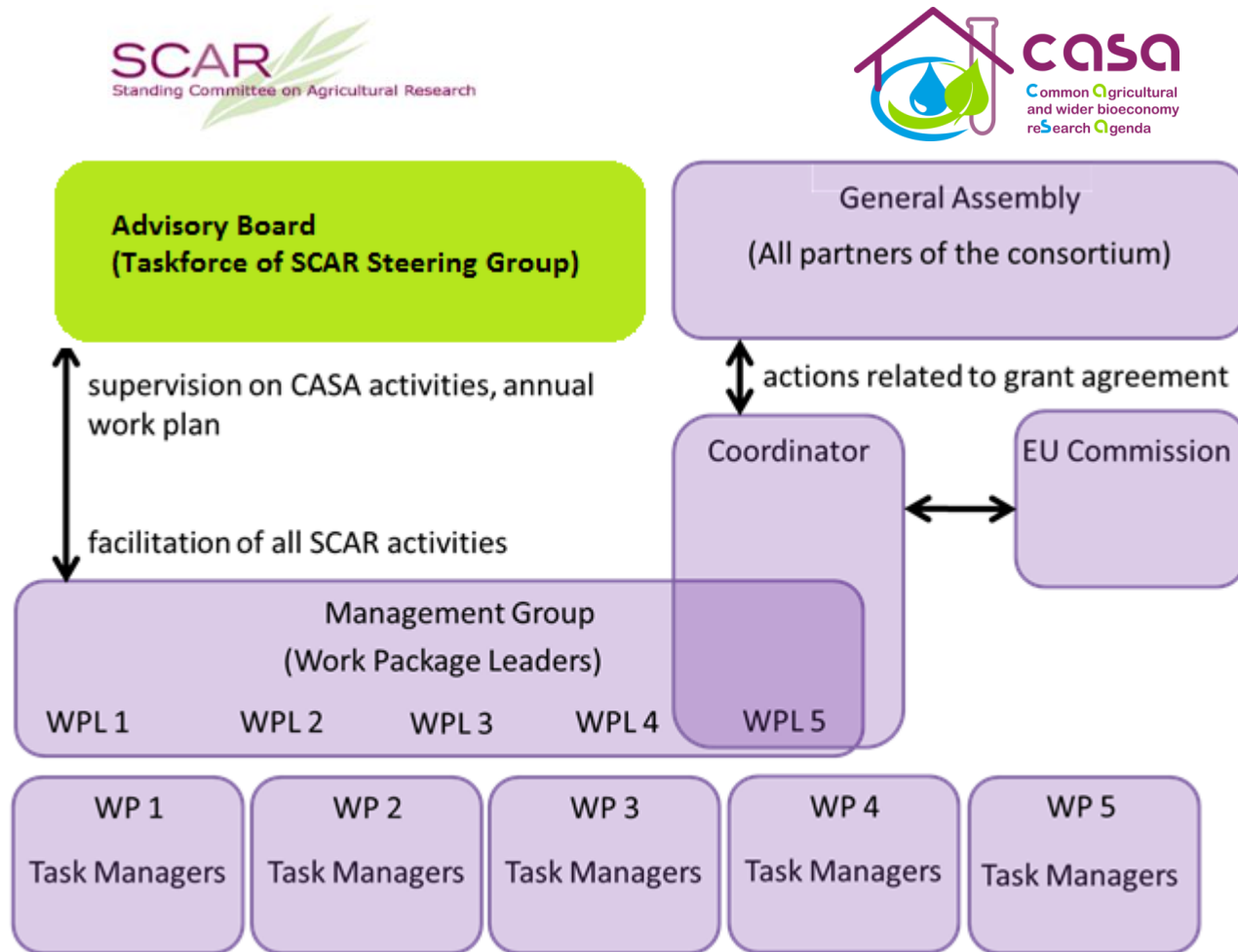

Rationale

- range of expertise to bring in
- bridging gaps between ministries at national level

How to get answers concerning representativeness?

- i. A desk study of SCAR meeting reports;
- ii. Interviews with chairs of SCAR groups;
- iii. Survey among national delegates;
- iv. Moderated discussions in working groups.

This should be done by supporting SCAR through **facilitation and coordination of the working groups**, thus helping deliver **results of improved quality** leading to **greater impact** of SCAR activities.

CASA WP2 Overview

The **objective** of this work package is to **support SCAR and its SWGs and CWGs** to deliver results of **improved quality** creating added value to outputs for **greater impact** within the evolving landscape of the broader bioeconomy.

CASA WP2 Tasks

WP 2 will provide support to working groups (SWG, CWG, Foresight Group & SCAR SG) through 5 tasks:

- T2.1 **Added Value** and Improved quality for greater impact
- T2.2 **Facilitation** of organisation of working groups and their meetings

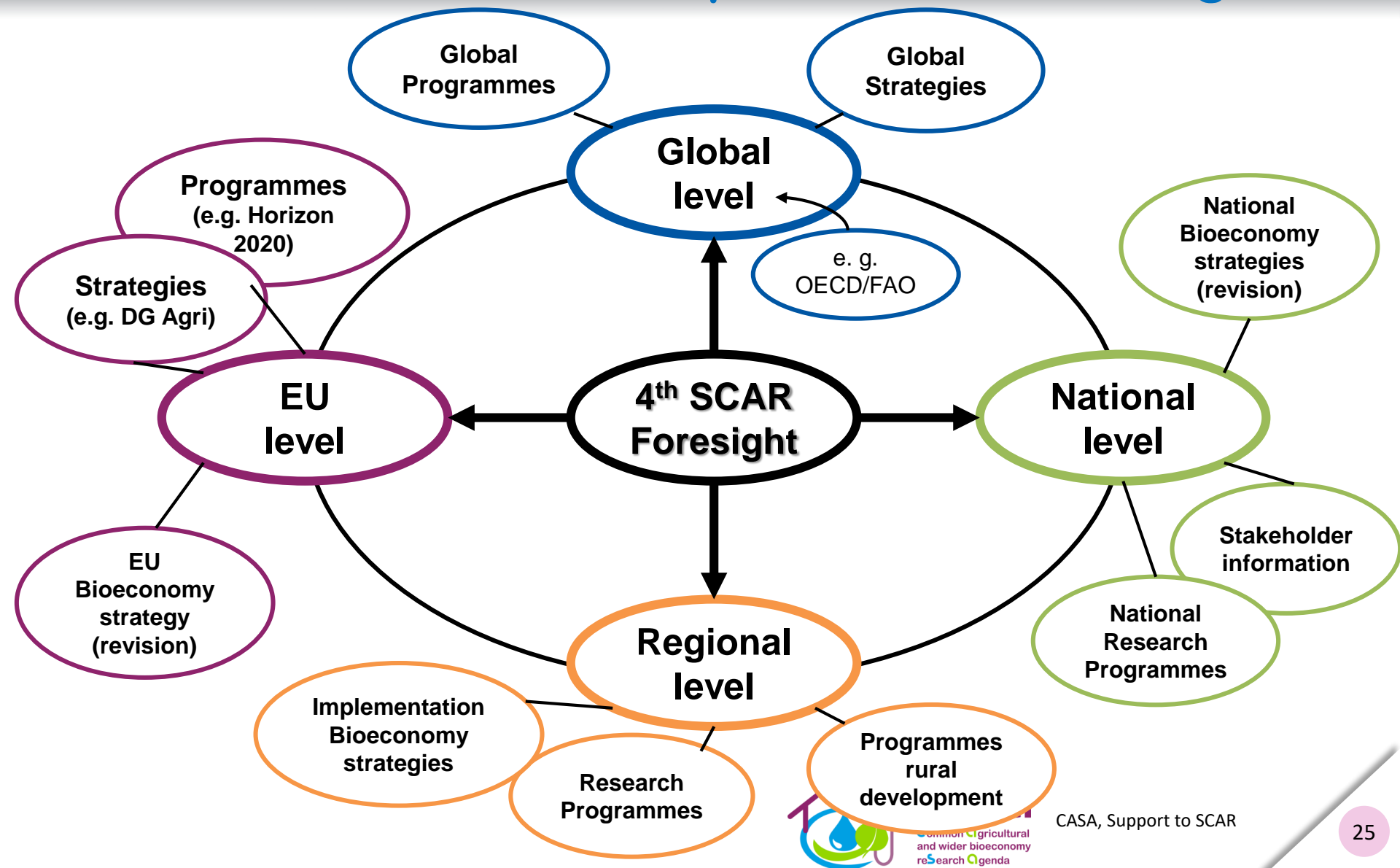

WP4: Communication and Dissemination

WP4 Objectives

- To ensure **adequate knowledge transfer and dissemination** of SCAR activities in order to achieve high impact of the results on the research community, the stakeholders and other interested parties
- **Improved links** between the SCAR activities
- The SCAR reports/studies need to be disseminated nationally and internationally to stakeholders and end-users
- The **impact of SCAR** activities is to be **reinforced**.

T 4.2 Various activities 1/3

- CASA style guide, templates, logo have been and will be further developed.
- Make the SCAR reports more attractive so that they can be a basis for discussion in the plenary sessions of SCAR.
- Eventually, in collaboration with WP2, elaborate leaflets on specific themes (2/3 per year) in various working languages of the European Union.

- Publication of SCAR reports in the format of leaflets, newsletters, or brochures:

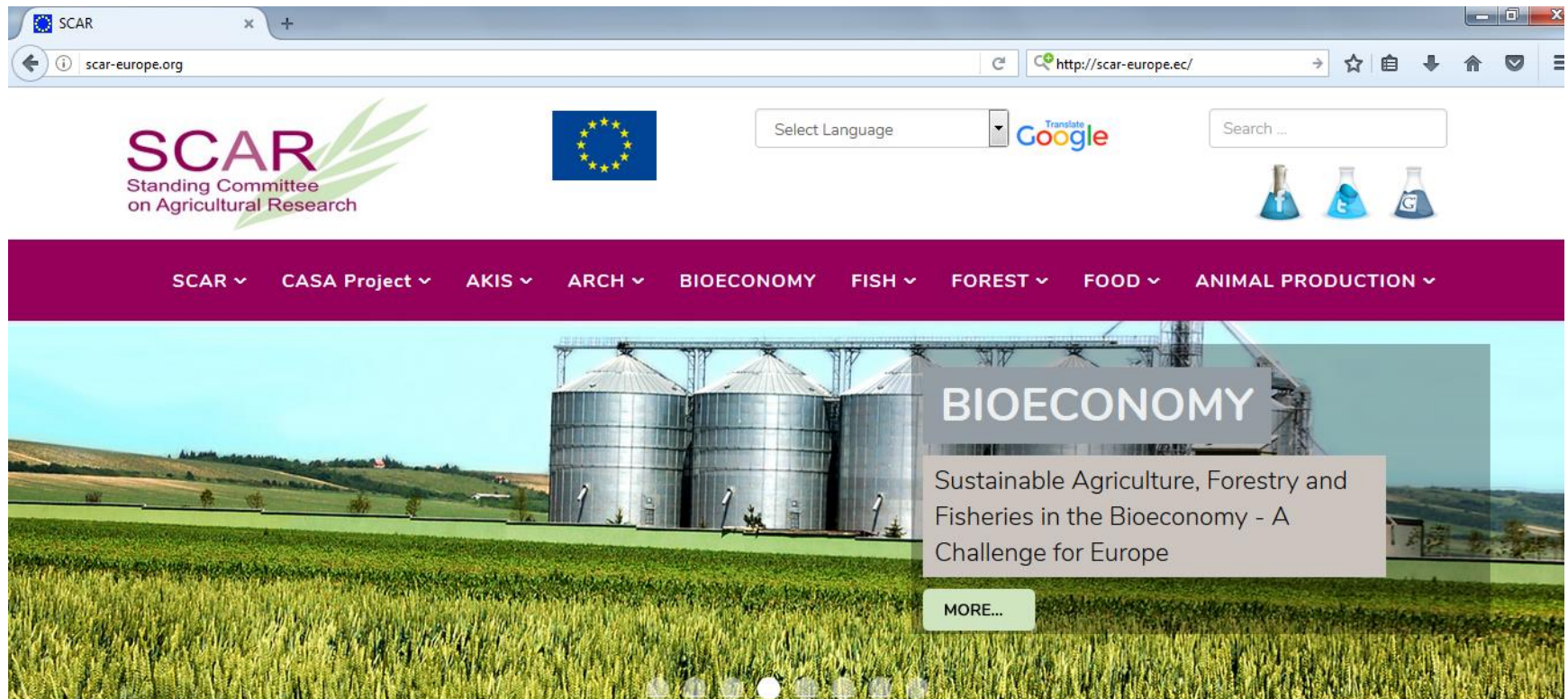
Bioeconomy issues, dictionary and best practices, based on the work of the bioeconomy SCAR working group, and for sake of sustainability

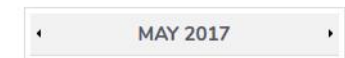
- A light web site for CASA which with two components:

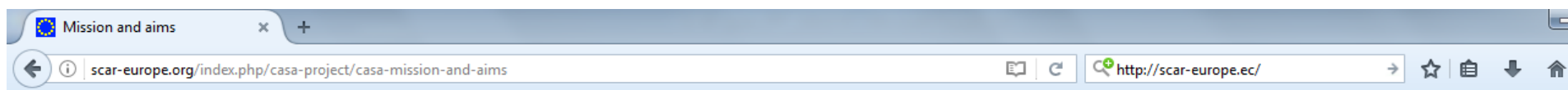

The overall objective of CASA is a consolidated common agricultural and wider bioeconomy research agenda within the European Research Area. The common research agenda will be jointly shared by Member States of the European Union and Associated Countries. It will improve the alignment and interoperability of the respective national research programme(s). This will be achieved through enhanced cooperation,

coordination and information exchange between the Member States, Associated Countries and the European Commission. This includes increasing the opportunities for Member States and Associated Countries to engage in the aforementioned activities. The conduit for this will be the Standing Committee of Agricultural Research (SCAR) and the various SCAR working groups, through which all Member States and Associated Countries are brought together with a view to fostering cooperation, coordination and information exchange, as well as streamlining research policy, in the Bioeconomy and closely related fields. The overarching aim of CASA will be achieved through the accomplishment of the following four specific objectives:

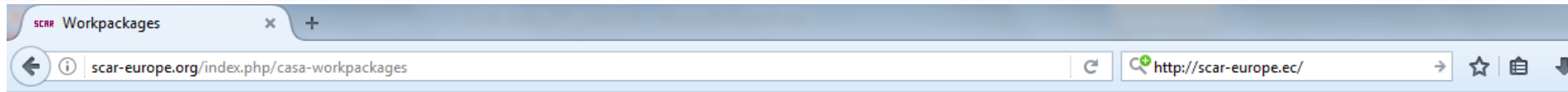
